

General Education Committee Meeting Minutes 3/27/2012

Meeting began at 3:30pm

I. New General Education Coordinator

- A. Dr. Khawaja solicited committee feedback about the selection of the new Gen Ed Coordinator. Members of the committee said that they felt it was important that the coordinator be even-tempered and that the most important job of the coordinator in the upcoming year was to work on the assessment of general education
- B. Candidates are,
 - 1. Joseph Palardy, Economics
 - 2. Rick Gaydos, Computer Science and Information Systems
 - 3. John Sarkissian, Foreign Languages

II. Old minutes - approved.

III. Upper-Division Courses in Gen Ed

- A. A list of upper-division courses included in the general education model that are required by accredited programs was distributed
- B. Possible Solutions
 - 1. Work on courses on a case-by-case basis in Gen Ed Committee.
 - 2. Cap courses that would count as double-dippers; courses that can be used to meet Gen Ed requirements and in count towards the major (based on prefix: ENGL, GERO, etc.).
 - a) Without restrictions, a very large share of the course requirements could be met by taking courses in a single department
 - b) How do we define "major", is it by department code (so, all PSYC, PHIL, etc.) or courses in major, which may vary in department code?
 - 3. Upper division courses OK if pre-reqs are also in Gen Ed.
- C. Discussion
 - 1. More class variety makes assessment more difficult
 - 2. The committee could revisit the issue of whether to only include introductory courses in general education (Introductory courses do not presuppose prior knowledge about field)
 - 3. Hold off until Domain Committees finish meeting to help define LO criteria?
 - 4. Problems with course limitations or exceptions—seems arbitrary.
 - 5. Questioned whether choosing 3700 level as a cutoff point is arbitrary and that the exceptions didn't seem appropriate

D. Summary of Next Steps:

- 1. We do nothing/ wait for feedback from Domain Committees.

2. Take current proposal to Senate (with modified language, see below).
3. Develop a cap based on department/program (So, no more than 2 courses can count for Gen Ed from the same dept./program).

* O'Mansky calls for straw-poll vote: Do we proceed and peruse limitation of upper-division courses OR do we proceed and develop language for caps based on department or programs?

- Results show most of the committee is OK with policy as written but acknowledge some changes must be made.
- Several members also interested in developing cap system.

* Stringer recommends not sending this through Senate at this point.

* If we postpone, we must make decision by May Senate meeting.

* We need advisors' feedback on cap system.

* Current language is elitist—why only accreditation concerns; what about other programs and their concerns?

* Members write language for cap option.

* Dr. Porter will talk to the advisors.
